Government have provided an amount of Rs. 3.00 Crores [Rupees Three Crores only] to meet the day to day contingent expenditure to run the administration of the colleges in the state, also issued B.R.O administrative sanction for an amount of Rs.45.00 Lakhs [Rupees Forty five Lakhs only] as first instalment in the reference 2nd and 3rd read above, an amount of Rs.44,16,800/- has been utilized and also issued BRO and Administrative for an amount of Rs.45.00 Lakhs as 2nd instalment in the reference 3rd and 4th read above. There is a balance of Rs.83,120/- is available from 1st instalment.

Sanction is hereby accorded for an amount of **Rs.45,47,583/- [Rupees Forty Five Lakhs Forty Seven Thousand Five Hundred Eighty Three Only]** to the Principal of Government Junior College and Government Vocational Junior college in the state as shown in the **annexure I & II** appended to these proceedings to meet the day to day contingent expenditure to run the administration of the college.

The Principal of the concerned college is requested to prefer the bill to the concerned Pay & Accounts Officer, District Treasury Officer, and Sub Treasury officer and draw the amount duly following the procedure as per rules in force. Any deviation in this regard will be viewed seriously and action will be initiated against guilty.
